Eligibility: To receive a parking permit, the vehicle must be registered to either a Dune Acres address or a single permanent address maintained by a Dune Acres property owner. Vehicles registered to other addresses, including those of family members and guests, should obtain a permanent or single-day guest pass from security.

CERTIFICATION AND HOLD HARMLESS FOR GOLF CART APPLICATIONS

I undersigned certify and state as follows:

1. I am the owner of the golf cart for which I am applying for a parking permit from the Town of Dune Acres, Indiana.
2. I have provided proof of liability insurance coverage for injuries arising from the use of the golf cart in an amount of \$25,000 or more. I understand that proof of such liability coverage must be available on the golf cart or carried by the operator at all time the vehicle is operated on the roads, streets, or thoroughfares of the Town of Dune Acres.
3. **That I will ensure that the golf cart shall only be operated by a licensed driver.**
4. The golf cart has been equipped with a rearview mirror, brakes, a "Slow Moving Vehicle" sign affixed to the back of the golf cart and seat belts. I understand that vehicles operated at night (after sunset and before sunrise), or at any other time when, due to insufficient light or unfavorable atmospheric conditions (e.g. fog, rain, etc.) the golf cart shall be equipped with headlamps and tail lamps visible from a distance of 500 feet.
5. That I shall hold harmless and agree to indemnify the Town of Dune Acres, Indiana, and its agents/representatives for damages stemming from injuries or other claims for loss arising from accidents involving my golf cart, whether the claim for said damages is by me or another person(s).
