General Requirements (*Municipal Code Chapter 34*)

One Vehicle Per Application

Resident Parking Permits will be issued only for vehicles that meet one of the following conditions:

1. The vehicle is registered to a Dune Acres property address; or
2. The vehicle is registered to an individual who is a Dune Acres property owner of record, as reflected on the most current Porter County property tax bill; or
3. The vehicle is registered to an individual who holds a valid residential lease of twelve (12) months or longer.

CERTIFICATION AND HOLD HARMLESS FOR GOLF CART APPLICATIONS

I the undersigned certify and state as follows:

- That I am the owner of the golf cart for which I am applying for a parking permit from the Town of Dune Acres, Indiana.
- That I have provided proof of liability insurance coverage for injuries arising from the use of the golf cart in an amount of \$25,000 or more. Additionally, I understand that proof of such liability coverage must be available on the golf cart or carried by the operator at all time the vehicle is operated on the roads, streets, or thoroughfares of the Town of Dune Acres.
- That I will ensure that the golf cart shall only be operated by a licensed driver.
- Where applicable, the golf cart has been equipped with a rearview mirror, brakes, a "Slow Moving Vehicle" sign affixed to the back of the golf cart and seat belts. I understand that vehicles operated at night (after sunset and before sunrise) or at any other time when, due to insufficient light or unfavorable atmospheric conditions (e.g. fog, rain, etc.) the golf cart shall be equipped with headlamps and tail lamps visible from a distance of 500 feet.
- That I shall hold harmless and agree to indemnify the Town of Dune Acres, Indiana, and its agents/representatives for damages stemming from injuries or other claims for loss arising from accidents involving my golf cart, whether the claim for said damages is by me or another person(s).

- Proof of liability insurance (golf carts only)
