## TOWN OF DUNE ACRES COUNCIL MINUTES September 23, 2015

The Town of Dune Acres Town Council met for its regular monthly meeting on Wednesday, September 23, 2015 at the Town Hall. Council President John Sullivan called the meeting to order at 7:00 p.m., with Council Members Rich Hawksworth and Lou Mellen and Clerk-Treasurer Carolyn Mellen and Attorney Dan Whitten in attendance. Council President Sullivan opened the meeting with the Pledge of Allegiance.

## SWEARING IN OF NEW CLERK-TREASURER:

Council Member Mellen moved to approve Jeannette Bapst as Clerk-Treasurer, seconded by Council Member Rich Hawksworth, and passed unanimously. Attorney Whitten administered the oath of office. Bapst is completing the term of outgoing Clerk-Treasurer Carolyn Mellen.

#### APPROVAL OF MINUTES:

Council Member Mellen moved that the minutes for the August 18, 2015 Town Council meeting be approved as presented. Council Member Hawksworth seconded, and the minutes passed unanimously.

Town Council Member Hawksworth moved that the financial report be accepted. Town Council Member Mellen seconded, and the financial report was accepted.

## PAYMENT OF CLAIMS:

Council Member Hawksworth moved the claims for the month of September 2015 in the amount of \$54,503.73 be approved. Council Member Mellen seconded and the motion passed unanimously.

## CORRESPONDENCE RECEIVED:

A letter from the Indiana Public Access Counselor was received in response to a formal complaint filed by Dune Acres resident Cheryl Evans. Evans' complaint alleged the Town violated the Access to Public Records Act. It was the opinion of the Counselor "that the Town of Dune Acres and the Town of Dune Acres Plan Commission has not violated the Access to Public Records Act."

#### **COMMISSIONERS REPORTS:**

BEACH: Council Members reported that the buoys had been removed. One was lost this year.

BUILDING: Rich Hawksworth moved for approval of a demolition permit for the fire damaged house at 6 Shore Drive, pending receipt of necessary documents, seconded by Council Member Mellen, and passed unanimously. Hawksworth also informed the Council that a building permit application and payment were received for improvements at 15 Oak Drive. The permit was approved by the council at its February meeting.

ENVIRONMENT: Council Member Hawksworth reported that the fall Town Clean-up has been scheduled for October 24<sup>th</sup>. It was his understanding that the chipper would be scheduled for the following weekend.

FIRE AND ENGINEERING: Mark Bapst and Irv Call reported on recent work completed on the clubhouse fire system. There was an issue with the compressor. Call and Bapst worked with State Line on testing the unit which is now in working order. The Council approved purchase of necessary equipment to complete a compressor timeclock indicator test. It was also reported that issues with existing alarm system connections (Frontier) and security camera data connections (Comcast) had been resolved.

MAINTENANCE: Council Member Mellen reported that Commissioner Dick Taylor requested consideration of purchasing a sickle bar mower in 2016 that would trim 3-4 feet along roadsides. Roadsides are now being manually trimmed with a weed wacker. Estimated cost is \$3,000. It was noted that trimming procedures along roads need to be addressed. Some areas are being cut too short, which may create erosion conditions, while other areas are increasingly overgrown with trees and shrubs, presenting driving and walking hazards. Purchasing a liquid salt spreader to be operated by Town maintenance personnel was also discussed. This may be reviewed in more detail in the future.

PARKS: Commissioner Kelly Klein requested a new skating rink liner and miscellaneous park supplies estimated to cost \$1500. Council Member Mellen motioned to approved expenditures, seconded by Council Member Hawksworth, and passed unanimously. Klein also reported that skating rink stairs would be installed soon and that a black tarp for covering the white liner during the summer was under consideration. She said a resident would make a Frisbee golf setup available for the Town next spring if a suitable location could be identified. Bill Nixon reported that tennis court work was complete (paid invoice on this month's claims docket.)

SECURITY: Commissioner Cecilia Call questioned whether her request for remote control gate access for the clubhouse entry drive was still under consideration. Council members stated that review of clubhouse use was underway by both the Council and the community at large through a Dune Acres Civic Improvement Foundation (DACIF) initiative. With new security cameras in place and new community uses of "clubhouse dune" anticipated, it is likely that the gates will be kept open for residents.

#### OLD BUSINESS:

Ordinance 2015-7, 2016 Budget, 1<sup>st</sup> reading. The Ordinance for the 2016 budget was read by title as previously reviewed at the 6:30 PM Public Hearing. Council Member Mellen moved to approve the ordinance on first reading, seconded by Council Member Hawksworth, and approved unanimously.

Ordinance 2015-06, Building Permit Fees, 2<sup>nd</sup> reading. Council Member Mellen motioned to approved the ordinance, seconded by Council Member Hawksworth, and passed unanimously. Ordinance adopted.

## NEW BUSINESS:

Discussion was held on changing the Town watercraft ordinance (chapter 42) to eliminate the permitting and permission to use personal water craft (PWC) – jet skis – in Dune Acres. The Council charged Attorney Whitten with reviewing the Ordinance and developing revised verbiage.

Information was provided on National Park Service (NPS) prescribed burns that are planned for several areas in Dune Acres and surrounding NPS parkland. The customary public notices will be distributed once dates and times are established. A motion for approval was made by Council Member Mellen, seconded by Council Member Hawksworth, and approved unanimously.

No discussion was held on the Doyle Property Agenda item as matters were still with the Plan Commission.

#### OTHER MATTERS:

Discussion was held regarding public access to Town beaches.
